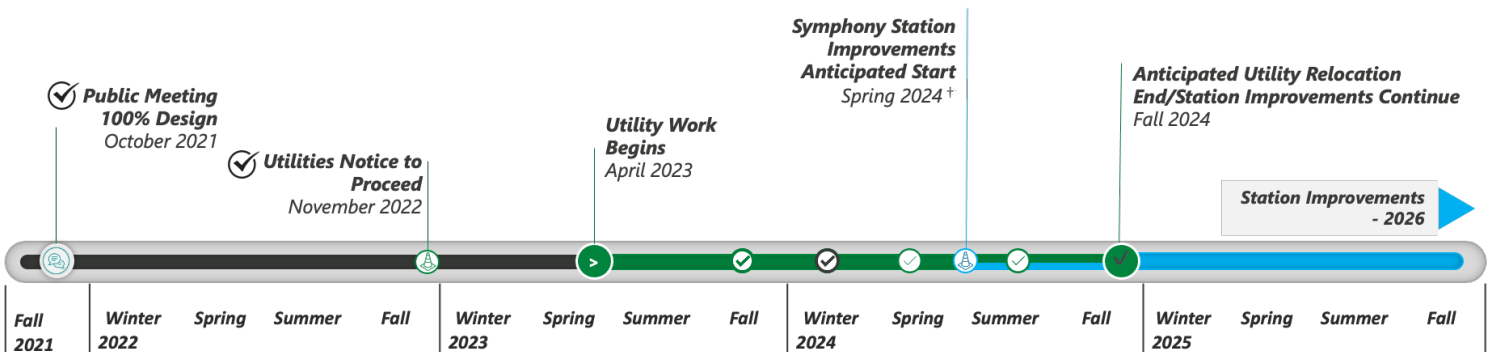
Accommodations
